 - The seniority of judges is determined by the number of years they have served as a judge of the Supreme Court, and it is not determined by their age.
 - In case two judges were sworn in as Supreme Court judges on the same day, the judge to take oath first would assume seniority.
 - Seniority of judges becomes the basis for the formation of the collegium and the line of succession for the post of CJI.
 - The recommendation of the seniormost judge of the Supreme Court is officially communicated by the incumbent CJI to the Ministry of Law and Justice, which, then, relays the communication to the Prime Minister as per the existing Memorandum of Procedure (MoP).
 - The Prime Minister advises the President on the recommendation and the executive head subsequently

makes the appointment under the powers conferred on her under Article 124(2) to make appointments of judges to India's top court.

2- (b)

- The scheme covers the entire urban area of the country, i.e., all statutory towns as per Census 2011 and towns notified subsequently, including Notified Planning/ Development Areas.
- The government had launched the Pradhan Mantri Awas Yojana (Urban) on June 25, 2015, to provide pucca houses to all eligible beneficiaries by 2022. The PMAY-U is one of the two schemes envisioned under the PMAY-U. It is focused on the urban areas, while the other one—PMAY-G—is for rural areas. The scheme has four "In-situ" Slum verticals: Redevelopment (ISSR); Credit Linked Subsidy Scheme (CLSS); Affordable Housing in Partnership (AHP) and individual Beneficiary-led house construction/enhancements (BLC).
- Under the BLC vertical, a beneficiary receives a financial assistance of Rs 2.5 lakh from the government to build his or her house. The PMAY-U guidelines define a beneficiary family as a family comprising of "husband, wife and unmarried [sons and/ or unmarried daughters.]"

 "The beneficiary family should not own a pucca house (an all-weather dwelling unit) either in his/her name or in the name of any member of his/her family in any part of India," state the scheme guidelines.

- It also provides, as part of the loan contract, a cooling-off/ look-up period during which the borrowers can exit digital loans by paying the principal and the proportionate annual percentage rate without any penalty.
- Banks will have to ensure that they, and the LSPs engaged by them, must have a suitable nodal grievance redressal officer to deal with fintechor digital lending-related complaints. This officer will also deal with complaints against their respective Digital Lending Apps (DLAs).
