- The fund is managed by the Employees' State Insurance Corporation (ESIC) according to rules and regulations stipulated in the ESI Act 1948.

• The Mudhol hounds are believed to have been bred first by Raja Malojirao Ghorpade of the erstwhile Deccan kingdom of Mudhol who, after seeing the qualities of the dogs that the tribals of his territory kept, decided to breed them selectively. The Raja is said to have presented a couple of these dogs to King George V on a visit to England, whereafter the breed got the name of Mudhol hound.

5- (a)

- It is a member of the family Flaviviridae, specifically from the genus Flavivirus, which also contains the Zika virus, dengue virus, and yellow fever virus.
- It is a single-stranded RNA virus that causes West Nile fever.
- There are no vaccines or medicines that specifically treat West Nile virus infections. Over-the-counter pain relievers can be used to help with

some symptoms and hospitalization may be necessary for more severe cases.

6- (c)

- It is important to note that the 0 6 years age group will be specifically managed at District Early Intervention Center (DEIC) level while for 6 -18 years age group, management of conditions will be done through existing public health facilities. DEIC will act as referral linkages for both the age groups.
- First level of screening is to be done at all delivery points through existing Medical Officers, Staff Nurses and ANMs. After 48 hours till 6 weeks the screening of newborns will be done by ASHA at home as a part of HBNC package. Outreach screening will be done by dedicated mobile block level teams for 6 weeks to 6 years at anganwadis centres and 6 - 18 years children at school.
- Once the child is screened and referred from any of these points of identification, it would be ensured that the necessary treatment/intervention is delivered at zero cost to the family.

- The scheme will be jointly funded by the central government and state governments, several states have come on board by signing the "Memorandum of Understanding" with the union government for this scheme.
- UDAN-RCS is both an enabler and a beneficiary of other key Government of India schemes, such as Bharatmala, Sagarmala, Dedicated Freight Corridors, Industrial corridor, BharatNet, Digital India and Make in India, National e-Governance Plan, Startup India and Standup India.

The scheme has been implemented in five phases so far:

- UDAN 1.0: 36 new airports commissioned. 128 flight routes for 70 airports were awarded to 5 airline companies.
- UDAN 2.0: It added helipad for the first time. In 2018, 73 unserved airports were announced.
- UDAN 3.0: This included tourist routes, seaplanes to connect water aerodromes and routes under 'UDAN' in the North-East region.
- UDAN 4.0: 78 new routes approved in 2020. In this phase, Kavaratti, Agatti and Minicoy islands of Lakshadweep will also be connected by new routes.

 UDAN 4.1: Its focus is on connecting small airports, special helicopter and seaplane routes under UDAN. New routes have also been proposed under Sagarmala seaplane services.

8- (c)

- India has inked FTAs with several countries, including the UAE, Mauritius, Japan, South Korea, Singapore, and ASEAN members.
- Under an FTA, the trading partners agree to significantly reduce or eliminate import/customs duties on the maximum number of goods traded between them, besides relaxing norms to promote trade in services and investments.
- The 'rules of origin' provision prescribes for minimal processing that should happen in the FTA country so that the final manufactured product may be called originating goods in that country.
- Under this provision, a country that has inked an FTA with India cannot dump goods from some third country in the Indian market by just putting a label on it. It has to undertake a prescribed value addition in that product to export to India. Rules of origin norms help contain dumping of goods.
